## **Message from the Chairman of the Press Complaints Commission of Sri Lanka**

The Press Complaints Commission of Sri Lanka (PCCSL) completed 15 years in existence in the year under review. Sri Lanka faced some grave constitutional challenges during the year, especially the 52 days in September-October when there was effectively no government. Fortunately the Supreme Court made an order that curtailed the stalemate.

The PCCSL continued its work in spite of such disruptions. Logistical assistance was also rendered to the Sri Lanka Press Institute (SLPI) to conduct an international conference on a review of the Colombo Declaration in September, which also celebrated its 20th anniversary.

The coming year (2019) may be a watershed in that there is every chance that the electronic media may join the print media to become the citizen's watchdog against poor reporting and fake news.

The CEO has assured us that a revamped website will be hosted shortly providing much needed information to journalists and students dealing on the work done by the PCCSL, as well as with the difficult subject of "ethics."

On behalf of the Press Complaints Commission, I wish to extend the Board's appreciation and gratitude to all our staff, our well-wishers and to those who gave us financial support, primarily the Editors' Guild of Sri Lanka.

## **Message from the Chairman of the Dispute Resolution Council**

The Press Complaints Commission of Sri Lanka (PCCSL) is an independent voluntary self regulatory mechanism, which was the outcome of the Colombo Declaration on Press Freedom and Social Responsibility, is now in its 15<sup>th</sup> year (founded on October 15, 2003).

It works on the principles of conciliation, mediation and arbitration under the Arbitration Act of 1995 and stands modeled along the lines of similar commissions in South Africa and Scandinavian countries.

During the current year, it has held 14 meetings successfully attended by publishers, editors, desk heads, sub editors, journalists and provincial correspondents. This voluntary independent self regulatory system has been accepted by all registered national newspapers of the country.

The PCCSL received 79 complaints, 48 from the Sinhala press, 12 from the Tamil press, 14 from the English press and 05 not against the print media. There was a total of 60 valid complaints and 19 invalid complaints. Direct complaints resolved outside of the PCCSL process or complaints handled directly by editors amounting to 243 complaints. These merited the publication of a 'Right of Reply' in the form of a clarification, correction or apology.

The Dispute Resolution Council (DRC) met on seven occasions and all meetings were well attended with the members contributing and assisting the work of the PCCSL.

The [www.pccsl.lk](http://www.pccsl.lk) Web Page continues to assist complainants who wish to know more about the PCCSL and the self regulatory mechanism and the way it functions through an Editors' Code and set of Rules and Regulations. It allows readers to make an online complaint. The PCCSL continues to upgrade the web page to accommodate results of complaints outstanding.

The Colombo Declaration, which formulates the basis of the PCCSL, celebrated its 20<sup>th</sup> anniversary (inaugurated in 1998) in September this year (2018), where some of the ideas to enhance and develop a free media were outlined.

Awareness programs with civil society (non journalists) made positive headway by meeting 50 people representing various sections of society at 14 meetings; the role of the PCCSL, Rules and Procedures of the PCCSL and the Editors' Code were explained.

I take this opportunity to sincerely thank all the members of the Dispute Resolution Council who have attended all the meetings regularly and assisted me in my task in no small way.

Finally, we wish to thank the PCCSL Secretariat headed by its energetic CEO Sukumar Rockwood and so ably assisted by Mr. Kamal Liyanaarachchi, Complaints Officer – Sinhala Print for upholding self regulation and its promotion in making the Newspaper Society (publishers) responsible.

# **Press Complaints Commission of Sri Lanka (PCCSL) 2018 Annual Review**

## **01. Introduction**

The PCCSL, which was the outcome of the Colombo Declaration on Press Freedom and Social Responsibility, celebrated its 20<sup>th</sup> anniversary from September 27 to 30, 2018 coinciding with the United Nations designated International Day for the Universal Access to Information (IDUAI).

Going back 20 years, the Colombo Declaration was an outcome of an international seminar held in Colombo, organized by the Newspaper Society of Sri Lanka, The Editors' Guild of Sri Lanka and the Free Media Movement in association with the Sri Lanka Working Journalists Association, the World Association of Newspapers, the Commonwealth Press Union, the International Press Institute, Article 19 and the Media Institute of Southern Africa.

The PCCSL is an independent, voluntary, self-regulatory mechanism set up by the newspaper industry of Sri Lanka, which comprises the Newspaper Society of Sri Lanka, The Editors' Guild of Sri Lanka, the Free Media Movement and the Sri Lanka Working Journalists Association.

It works on the principles of conciliation, mediation and arbitration under the Arbitration Act No. 11 of 1995. It is modelled along the lines of similar Commissions in Scandinavian countries and South Africa. The High Court of Colombo is empowered to enforce an arbitration award made under the Act in the event a newspaper fails to publish the decision of the Dispute Resolution Council of the PCCSL should a complainant wish to pursue a case where the editor is not abiding by the arbitral decision.

The Editors' Code, which is implemented by the PCCSL, now provides for conditional third party complaints. Third party complaints are entertained from Environmental Groups, Animal Welfare Groups, Adults on behalf of minors, an immediate family member of an accident victim, an immediate family member of a person in custody and anyone complaining on behalf of another provided the prior written permission of the person personally affected is obtained.

## **02. Executive summary**

The Press Complaints Commission of Sri Lanka (PCCSL) continued building on the positive growth made in the previous year and successfully held 14 meetings attended by 118 publishers, editors, sub-editors, journalists and provincial journalists. During the meetings, the importance of self-regulation and the Editors' Code of Professional Practice were discussed along with the PCCSL process in resolving complaints.

The voluntary independent self-regulatory system is accepted by all registered National newspapers printed and published in the country. This can be measured in many ways:

(a) The number of valid complaints received, i.e. complaints received falling within the mandate of the PCCSL. However, complainants remain sluggish in following up on their initial (informal) complaint, while editors are eager to resolve them when informed.

(b) The number of complaints resolved directly by editors or 'instant complaints' has maintained stability indicating that editors continue to follow the self-regulatory process. The increased number of 'Right of Reply' responses in the form of corrections, clarifications, apologies published by Sri Lankan newspapers without formally involving the PCCSL indicates that the advocacy work done by the Commission has made readers write direct to editors and have their 'Right of Reply' published without the PCCSL getting involved.

(c) The PCCSL also observes violations of the Code and these are brought to the notice of the respective editors who respond positively by introducing positive steps in their newspapers which help reach the objective of a professional and responsible media.

(d) The PCCSL has been informed by several publishing houses that because of the intervention of the PCCSL in resolving complaints and training journalists, as to the use of the Editors' Code to guide them to be more professional and socially responsible when writing stories, publishers have been able to avoid going to court and facing hefty legal fees.

(e) The PCCSL sends the complainants' '**Opportunity to Reply**' - **Clause 04** of the Editors' Code – to editors for publication. Some newspapers have not published them in spite of several reminders. They are: *Yarl Thinakkural*, *Valampuri*, *Divaina* and *Daily News*. (Please see attached complaints chart for details).

#### **02.01. Press Council issues:**

In May, the Ceylon Newspapers (Pvt) Ltd, publishers of *Maubima* (Sinhala language daily/weekly) prepared documents to be presented to Court challenging the legitimacy of the Press Council. They sought the SLPI's and all media organisations concurrence that the Press Council is not a properly constituted body.

Meanwhile, *The Sunday Times* challenged the legality of the Press Council when a case came up against the newspaper. The Press Council however reconstituted the Council.

The Press Council was reconstituted and re-activated by the President on Thursday, July 05, 2018 with the following members. The new Board of Directors comprises: Advocate Koggala Wellala Bandula, Chairman; Prof Emeritus. Sunanda Mahendra; Muditha Kariyakarawana (Senior Journalist – President: Sri Lanka Press Association); Ariyananda Dombagahawatte (Senior Journalist – Editor *Irida Lankadeepa*); S. Thillainathan (Senior Journalist – former Editor *Thinakaran*); Mr. Somaweera Chandrasiri (trade union activist); Attorney-at-Law Sudarshaana Gunawardana (Director General, Govt. Information); Mr. Niroshan Thambawita, Press Commissioner. The new Board was appointed for three years.

Media organisations at a meeting in the SLPI Board Room, unanimously supported the SLPI going to Courts against the Press Council since it is not a properly constituted body. Meanwhile, the SLPI along with its constituent parties is in consultation with its lawyers on a further challenge to the legality of the Press Council.

### ***02.02. Meeting with the Mass Media Minister:***

Mass Media Minister Mangala Samaraweera on Monday, January 29, 2018 met along with Ministry officials, PCCSL/SLPI Board Chairman, Kumar Nadesan, The Editors' Guild of Sri Lanka President, Manik de Silva, Government Information Director-General, Sudarshana Gunawardana, Sri Lanka Working Journalists Association Secretary, Duminda Sampath, PCCSL CEO, Sukumar Rockwood, SLPI CEO, Kumar Lopez and PCCSL Sinhala Complaints Officer, Kamal Liyanarachchi. The role of the PCCSL and SLPI were discussed. It was decided to form a committee to discuss with other like-minded people to bring in the electronic media (TV/radio and online media) in a bid to reduce 'whacking people.' The Minister agreed that the Press Council should be abolished.

He recognised the role of the PCCSL as a suitable alternative but pointed out that it lacked teeth being a self-regulatory mechanism. However, the PCCSL has a system of naming and shaming, publishers each year through the PCCSL Annual Report.

He requested the setting up of a similar system to monitor the electronic media as well and promote the Editors' Code among them. Minister Samaraweera also pointed out two more issues; licensing of TV, radio and online newspapers. He also suggested monitoring of misleading advertisements in both the print and electronic media – the use of women and children in advertising should be avoided.

Turning to the financing of the PCCSL, he suggested a grant to run the affairs of the PCCSL.

### ***02.03. Proposed Independent News Media Council Act:***

The Independent News Media Council Act (Revised) Discussion Draft (July 21, 2017) facilitated by the National Secretariat for Media Reforms (NSMR) – a partner in the IREX/USAID/MEND Program – was forwarded to SLPI on May 14, 2018 along with questionnaire returnable by May 31, 2018. SLPI replied May 23 to Chief-of-Party, IREX/MEND Program Mr. Matt Shelley that, the SLPI subscribes to the Colombo Declaration on Media Freedom and Social Responsibility, which is supported by the constituent members: TEGOSL, NSSL, FMM and SLWJA and that its constituent members are willing to have a further discussion on the draft objectives based on the Colombo Declaration.

In June, the Independent News Media Council Act (Revised) Discussion Draft (July 21, 2017), was taken up for discussion with constituent members of both the SLPI and PCCSL Boards of Directors. Mr. Kumar Nadesan, Chairman of both Boards chaired the meeting. Around 15 concerns were raised. These were put forward to Mr. Sigard Sorenson, International Senior Lawyers Project, USA of IREX who had met many concerned media groups. His final report is awaited.

### ***02.04. 20<sup>th</sup> Anniversary of the Colombo Declaration***

The 20<sup>th</sup> Anniversary of the Colombo Declaration on Media Freedom and Social Responsibility was held from September 27 to 30. The inaugural ceremony was graced by Prime Minister Ranil Wickremesinghe, Mass Media and Finance Minister Mangala Samaraweera, the Leader of the Opposition Mr. R. Sampanthan was represented by



MP, M. Sumanthiram, Commonwealth Media Trust Director, Lindsay Ross, Royal Norwegian Ambassador Thorbjorn Gaustadsaether, UNESCO Director Eric Falt and the Sri Lanka Press Institute Board of Directors Chairman Kumar Nadesan. The Cinnamon Grand was the venue of the 20<sup>th</sup> anniversary and the Working Sessions were held at the Cinnamon Grand and the Mt. Lavinia Hotel.

#### ***02.05. Proposed draft Act (Sri Lanka Media Authority Act)***

Following the 20<sup>th</sup> anniversary of the Colombo Declaration on Media Freedom and Social Responsibility held in September, Mr. Dieter Loraine, Managing Director, Albany Associates Limited, UK was tasked with outlining a draft Act including concerns, articulated at the 20<sup>th</sup> anniversary of the Colombo Declaration and the Independent News Media Council Act (Revised) Discussion Draft (July 21, 2017). Mr. Loraine together with Ms. Lindsay Ross of the Commonwealth Media Trust held informal discussions with representatives of The Editors' Guild of Sri Lanka (TEGOSL), the Newspaper Society of Sri Lanka (NSSL), the Sri Lanka Working Journalists Association (SLWJA), the Free Media Movement (FMM) and the Sri Lanka Press Institute (SLPI) on a proposed draft of SLPI's constituent parties.

#### ***02.06. Gender issues:***

A midst the predominantly male-dominated editors, there are four women editors (Ms. Pushpa Rowel, Editor, Dinamina newspaper, Ms. Hana Ibrahim, Editor, Daily/Weekend Express, Ms. Dharisha Bastian, Editor, Sunday Observer and Ms. Mandana Ismail Abeywickrema, Editor, the Sunday Morning) and quite a few women sub-editors, news editors, features editors and supplement editors.

#### ***02.07. PCCSL and RTI***

The PCCSL continued to assist the SLPI to promote the Right to Information (RTI) in the Provinces by conducting five programmes in five districts (Badulla, Kandy, Nuwara Eliya, Anuradhapura and Galle) covering the three language streams, Sinhala, Tamil and English. A total of 125 male and 75 female youth attended these programmes. This programme was assisted by Mr. Kamal Liyanarachchi, Complaints Officer, Sinhala Print of the PCCSL.

#### ***02.08. Total number of newspapers monitored and their frequency***

Total number of dailies and weeklies published in the three language streams at the commencement of 2018 was 43. However, at the end of December 31, 2018 there were 39 dailies and weeklies published in the three language streams.

The newspapers that closed during 2018 were: Sinhala language - Rivira daily and weekly and Lakbima daily newspapers, Tamil language – Sudar Oli daily and weekly and English language – The Nation and The Sunday Leader newspapers.

In Jaffna, the Yarl Thinakkural, Uthayan, Valampuri and Kalaikathir are published in Jaffna. Kandy and Batticaloa also have their regional newspapers

### **03. Complaints**

During the period under review (January to December 2018), the PCCSL received **79** complaints. The following is a breakdown of the complaints as against the different language newspapers.

- \* Against the Tamil language press: **12** complaints.
- \* Against the English language press: **14** complaints.
- \* Not against the print media: **05** complaints

### **03.03. Other complaints:**

The PCCSL also received a few complaints against non-payment of prize-money for crossword puzzles, purportedly misleading advertisements published in newspapers, advertorials (Editorial content paid for appearing as a story), articles sent for publication that were not published, as well as complaints against the electronic media. Most of the complaints were made over the telephone, However, those that were sent in writing were forwarded to the relevant authorities. There were also complaints of a personal nature which could not be addressed by the PCCSL.

### **03.04. Complaints resolved outside of the PCCSL process (direct complaints):**

The PCCSL monitors the daily progress made by Editors in resolving complaints without involving the PCCSL (direct complaints) and has observed that a total of 243 complaints have been resolved during the year with the publication of a clarification, correction, apology or Right of Reply. This includes 159 concerning Sinhala newspapers, 06 Tamil and 78 English. (please see attached chart)

### **03.05. Violations of the Code monitored by the PCCSL:**

The PCCSL, during the year, monitored violations of the Code in 40 instances in 18 newspapers (**Sunday Observer, Daily News, Dinamina, Thinakaran, Lakbima, Sudar Oli, Thinakkural, The Island, Divaina, Rivira, Metro News, Virakesari daily and weekly, Daily Mirror, Ceylon Today, Maubima daily and weekly, Navamani**, (please see attached chart)

## **04. Rights of Readers**

The 'Rights of Readers' advertisement was published as a public service notice and was sent to all newspapers for publication. The following newspapers carried the public notice on a regular basis while some publishing it on and off.

Meanwhile, the Ceylon Today (Daily Edition), Ceylon Today (Sunday Edition), Maubima (Daily Edition) and Maubima (Sunday Edition), Divaina, Irida Divaina and Silumina continue to comply with the PCCSL process but do not publish the 'Right of Readers' public notice.

#### **05. Dispute Resolution Council**

The Dispute Resolution Council (DRC) met on seven occasions (January, March, May, June, August, October and December). The Chairman of the 11-member Dispute Resolution Council is former Secretary General of Parliament and Attorney Nihal Seneviratne. The other members are: Dr. Devanesan Nesiiah, Mrs. Gnana Moonesinghe, Mr. Lucille Wijewardene, Mr. Javid Yusuf and Mr. Dion Schoorman, who are non-journalist members of the Council totalling six. Mr. Siri Ranasinghe, Mr. Pramod de Silva, Mrs. Vijita Fernando, Mr. Daya Lankapura and Mr. P. Balasingham, are the journalist members on the Council totalling five. Mrs. Vijita Fernando stepped down due to poor health early in the year. Ms. Malini Govinnage was selected to replace her and resigned in December due to poor health.

#### **06. Membership of PCCSL**

Membership of the PCCSL stands at 48 as of December 31, 2018 with the demise of Mr. Jatila Wellaboda.

#### **07. Awareness and Promotional Programmes**

##### ***07.01. Web Page***

The web page – [www.pccsl.lk](http://www.pccsl.lk) - continued to grow with 18,200 hits recorded since it was inaugurated on January 01, 2013. The Web Page makes it easier for complainants to learn more about the PCCSL, its activities, the Code of Professional Practice, the Colombo Declaration and how to make online complaints. The web page is updated with the latest information.

##### ***07.02. Programmes with publishers, Editors, journalists and provincial correspondents***

The PCCSL conducted a total of 14 meetings for 118 people comprising publishers, Editors, Desk Heads, sub editors and journalists (reporters). The PCCSL also visited 05 Districts and conducted programmes for provincial correspondents. (Please see awareness chart).

##### ***07.03. Awareness programmes with civil society***

The PCCSL also made positive headway by meeting 50 members representing various sections of civil society at 14 meetings. The role of the PCCSL, Rules and Procedures of the PCCSL and the Editors' Code were explained. These programmes were well

attended by principals of schools, teachers, government officials, military and police personnel, local government institutions, academics, doctors and the Directors of Education. They were eager to know more about the PCCSL and how it works. (Please see awareness chart).

#### **08: Closure/change of hands of newspapers and new publications:**

2017 was an economically bad year for the newspaper industry and spilled over into Year 2018, poor advertising revenue and circulation, soaring production costs due to further depreciation of the Rupee against the US Dollar forcing some newspapers to change hands while some ceased production.

Following are the affected newspapers:

- The *Sudar Oli* newspaper (Tamil language daily/weekly), ceased publication.
- *Janayugaya* (Sinhala language daily/weekly), ceased publication.
- *Sathhanda* (Sinhala language weekly), ceased publication.
- *The Nation* (English language weekly), ceased publication.
- *Rivira* (Sinhala language daily/weekly), management and Editorial changes. Ceased publication.
- *Ravaya* (Sinhala language weekly), change in management and Editorial.
- *Anidda* (Sinhala language weekly), launched.
- *Resa* (Sinhala language daily), launched.
- the Sunday Morning (English language weekly), launched.
- Sathi Aga Aruna (Sinhala language weekly), launched.

#### **09. Newspaper industry and security situation of journalists**

##### **January**

##### **Media guidelines introduced when election reporting:**

Following the Gazetting of the 32-point new media law governing coverage of elections, it was presented to Parliament and passed after a brief debate. Prime Minister Ranil Wickremesinghe signed the Gazette on January 02, 2018.

- The Sri Lanka Press Association held its 62<sup>nd</sup> Annual General Meeting.
- Ms. Dharisha Bastians appointed Editor of the *Sunday Observer*.

##### **April**

- May 31, 2018: Mr. U. K. Kaldeen, Freelance Correspondent was attacked by a group of thugs at 5.30 am in Sainthamaruthu while he was on his way home after prayers. His motorcycle was also damaged. (Source: *Ceylon Today*).

- Mr. Chamara Lakshan, Editor *Resa* newspaper appointed Editor of *Silumina*.

## June

### **Closure/change hands of newspapers:**

- Mr. Chaminda Wariyagoda, appointed Editor of *Silumina* newspaper following the sudden demise of Mr. Chamara Lakshan.
- Mr. Philips Shantha, appointed Editor of *Resa* newspaper.

## July

- *Saba* (Sinhala language tabloid weekly), edited by Mr. Bandula Padmakumara was launched in July. It closed later in the year.
- *Siyadesa* (Sinhala language weekly), published by Express Newspapers (Ceylon) (Pvt) Ltd, in June ceased publication.

## August

- August 14, 2018: Free Media Movement (FMM) condemns alleged threat on journalist by Dr. Anuruddha Padeniya, President of the Government Medical Officers Association (GMOA). The journalist of the *Sunday Observer* was called a traitor in a press release.
- The English language version of the Social Media Declaration, Sri Lanka 2018 – Code of Conduct for Responsible Social Media Use, undertaken by the CPA was shared with the PCCSL on Aug. 16. The CPS requested the PCCSL's response. Mr. Kamal Liyanaarachchi, Complaints Officer – Sinhala Print was invited to be a member of the panel.
- *Sudar Oli* that was closed re-opened Aug. 26 as a weekly newspaper out on Sunday. The editor Mr. R. Sivaraja is planning on investing and taking ownership.
- *Dan Irida* a tabloid weekly Sinhala newspaper has been published the past month by Saptna Media Corporation (Pvt) Ltd. The editor is Mr. Thushara Guneratne assisted by Mr. Upul Joseph both formerly of *Janayugaya* which has closed.

## September

- The seventh English language weekend (Sunday) newspaper was released in September published by the Derana Group. It is '*the Sunday Morning*' and the Sinhala language issue is '*Sathi Aga Aruna*.' Mr. Dilith Jayaweera is the MD. The other six weekend (Sunday) newspapers are: *The Sunday Times*, *Sunday Observer*, *Sunday Island*, *Ceylon Today (Sunday Edition)*, *Weekend FT* and *Weekend Express*.

## October

### **Attacks against media personnel:**

- A Valampuri journalist – Uthayarasa Shalin was being harassed by the TID for publishing a photograph of the inside of a Hindu Temple where a religious

ceremony was taking place depicting the Tamil Homeland map in the background. Reporters Without Borders (RSF) called upon the government to stop harassing the journalist.

### **November**

- Nov. 02, was 'International Day to End Impunity for Crimes Against Journalists.' An article 'A new level of audacity for impunity and journalist murders' sent by Mr. Andrew Heslop, Director Press Freedom WAN-IFRA was published in Daily FT (Nov. 02). Daily Mirror (Nov. 02) also featured an article on the 'Third Asian Investigative Journalism Conference,' in Seoul.

### **Attacks against media personnel:**

- Nov. 19, Damitha Chandrasiri (41), script writer and Editor of 'koombiyo,' tele drama on ITN has been missing for past three weeks (last seen Oct. 29) police said on Nov. 18, 2018.

### **December**

- The *Lakbima* Daily newspaper published by the Sumathi Group ceased publication on Dec. 01, 2018.
- The *Irida Rivira* ceased publication on Dec.02, 2018. Earlier the *Rivira Daily* ceased and before that *The Nation* newspaper.
- On Dec. 05, 2018 Speaker Karu Jayasuriya summoned the Secretary to the Ministry of Media Mr. Sunil Hettiarachchi and acting Chairman of the Sri Lanka Broadcasting Corporation (SLBC) Mr. Somarathna Dissanayake to Parliament following complaints by several MPs that state media institutions are not publishing Parliamentary reports accurately and without bias. The Speaker made it clear that there is no Prime Minister and Cabinet in the country. The media institutions are: Sri Lanka Broadcasting Corporation (SLBC), Sri Lanka Rupavahini Corporation (SLRC), Independent Television Network (ITN) and newspapers published by the Associated Newspapers of Ceylon Limited (ANCL) (Lake House). SLBC acting Chairman also expressed regret at stopping the live telecast of Parliamentary proceedings and would recommence broadcasting it.
- Mr. Mangala Samaraweera, re-appointed Minister of Finance and Mass Media Dec 21, 2018 following the political crisis. Lake House along with SLRC, SLBC and ITN come under his purview.
- Mr. Chrishantha Cooray re-appointed as Chairman, ANCL.

### **10. AGM, Board meetings and PCCSL Secretariat**

The PCCSL Board of Directors continued to meet once a month. The Annual General Meeting (AGM) took place on September 12, 2018.

# **Code of Professional Practice (Code of Ethics) of The Editors' Guild of Sri Lanka adopted by the Press Complaints Commission of Sri Lanka**

## **01. PREAMBLE**

This code of practice, which is binding on newspaper publishing companies, Editors and their journalists and contributors both in print format and online, aims to ensure that the Sri Lankan press is free and responsible and sensitive to the needs and expectations of its readers, while maintaining the highest standards of journalism.

Those standards require newspapers to strive for accuracy and professional integrity, and to uphold the best traditions of investigative journalism in the public interest, unfettered by distorting commercialism or by improper pressure or by narrow self-interest, which conspires against press freedom. Newspapers and journalists, while free to hold and express their own strong opinions, should give due consideration to the views of others and endeavour to reflect social responsibility.

This code both protects the rights of the individual and upholds the public's right to know. It should be honoured not only to the letter but in the spirit – neither interpreted so narrowly as to compromise its commitment to respect the rights of the individual nor so broadly as to prevent publication in the public interest.

Editors should co-operate swiftly with the Press Complaints Commission of Sri Lanka (PCCSL) in the resolution of complaints. Any publication judged to have breached the Code must print the adjudication in full and with due prominence, including a headline reference to the PCCSL.

## **02. ACCURATE REPORTING**

2.1: The media must take all reasonable care not to publish inaccurate, misleading or distorting news, photographs and other images. Any significant digital manipulation of images should be labelled.

2.2: Every reasonable attempt should be made by editors and individual journalists to verify the accuracy of reports prior to publication. Where such verification is not practicable, that fact shall be stated in the report.

2.3: Editors and their staff, including external contributors, shall not publish material in such a way as to endorse any matter which they know or have reason to believe to be false or inaccurate.

2.4: Plagiarism must be avoided. Legitimate use of other people's work should be duly attributed.

2.5: The press must distinguish clearly between comment, conjecture and fact.

### **03. CORRECTIONS and APOLOGIES**

3.1: Where it is recognized by the editor that a report was incorrect in a material respect, it should be corrected promptly and with due prominence and with an apology where appropriate, except where the correction or apology is against the wishes of the aggrieved party.

### **04. OPPORTUNITY TO REPLY**

4.1: A fair and reasonable opportunity to reply should be given to individuals or organizations in respect of factually incorrect statements endangering their reputation, dignity, honour, feelings, privacy and office. The mutually agreed reply should be confined to the complainant's version of the facts and no longer than necessary to correct the alleged inaccuracy.

4.2: Newspapers or journalists who respond to a complainant's reply other than to apologize or regret the error, must then be prepared to offer the aggrieved party a fresh opportunity to reply.

### **05. CONFIDENTIAL SOURCES**

5.1: Every journalist has a moral obligation to protect confidential sources of information, until that source authorizes otherwise.

### **06. GENERAL REPORTING and WRITING**

6.1: In dealing with social issues of a particularly shocking or emotionally painful nature – such as atrocity, violence, drug abuse, brutality, sadism, sexual salacity and obscenity – the press should take special care to present facts, opinions, photographs and graphics with due sensitivity and discretion, subject to its duty to publish in the public interest.

6.2: In reporting accounts of crime or criminal case, publications shall not, unless it is both legally permitted and in the public interest –

- i. Name victims of sex crimes.
- ii. Knowingly name any young person accused of a criminal offence who is below the age of 16 and who has no previous convictions.
- iii. Identify without consent relatives of a person accused or convicted of a crime.

6.3: A journalist shall not knowingly or wilfully promote communal or religious discord or violence.

6.4: i. The press must avoid prejudicial or pejorative reference to a person's race, colour, religion, sex or to any physical or mental illness or disability.

ii. It must avoid publishing details of a person's race, caste, religion, sexual orientation, physical or mental illness or disability unless these are directly relevant to the story.

6.5: When reporting suicide, care should be taken not to give excessive detail of the method used.

## **07. PRIVACY**

7.1: The press shall exercise particular care to respect the private and family lives of individuals, their home, health and correspondence, including digital communications. Intrusions on this right to privacy without consent could be justified only by some over-riding public interest.

7.2: The use of long-lens or other cameras to photograph people without consent on private or public property where there is a reasonable expectation or privacy is unacceptable, unless in the public interest.

7.3: Particular care should be taken to ensure that in cases involving grief or shock, inquiries and approaches are handled with sensitivity and discretion.

7.4: Young people should be free to complete their school years without unnecessary intrusion. Publication of material concerning a child's private life would be acceptable only if there was some exceptional public interest other than the fame, notoriety or position of his or her family or guardian.

7.5: The restrictions on intruding into privacy are particularly relevant to inquiries about individuals in hospitals or similar institutions, unless it serves the public interest.

## **08. HARASSMENT and SUBTERFUGE**

8.1: Journalists, including photo-journalists, must not seek to obtain information or pictures through intimidation or harassment or by misrepresentation or subterfuge. The use of long-lens cameras or listening devices, or interception of private or mobile telephone calls, e-mails or messages is unacceptable unless this can be justified in the public interest and the material could not have been obtained by other means.

## **09. INTEGRITY**

9.1: All journalists should act with integrity and honour in the performance of their work.

9.2: Conflicts of interest should be avoided. Journalists should inform their editor or responsible superior of any possible conflict, such as close personal connection with any story in which they are significantly engaged; or acceptance or offers of gifts that might compromise their integrity. If such conflict is unavoidable, it should normally be disclosed to the reader.

9.3: i. Even where the law does not prohibit it, journalists must not use for their own profit financial information they receive in advance of its general publication, nor should they pass such information for the profit of others.

ii. They must not write about shares or securities in whose performance they know that they or their close families have a significant financial interest, without disclosing the interest to the publisher, editor or financial editor.

9.4: Articles written for payment or other benefit from a commercial or other non- editorial source, such as in advertorials or promotions, should be clearly labelled as such.

Payment should not be sought or accepted as a reward for including favourable – or excluding hostile – editorial material.

## **INTERPRETATION**

1: Public Interest' means:

i. Protecting democracy, good governance, freedom of expression, human rights and keeping the people informed of the actions of their elected representatives and government.

ii. This also includes, but is not confined to:

- Detecting or exposing crime or the threat of crime;
- Disclosing a person or organisation's failure or likely failure to comply with any legal obligation to which they are subject;
- Disclosing a miscarriage of justice;
- Raising or contributing to an important matter of public debate, including serious cases of impropriety, unethical conduct or incompetence concerning the public;
- Disclosing concealment, or likely concealment, of any of the above;
- Protecting public health and security and social, cultural and educational standards;
- Protecting the public from being misled by some statement or action of an individual or organisation.

2: In any case where the public interest is cited, the Press Complaints Commission will require the Editor and/or journalist to demonstrate that the breach was proportionate to the public interest served.

## **ONLINE PUBLICATIONS**

The provisions of this Code will also apply to the Online publications of the print media, where:

- The editor of the newspaper, magazine, or freestanding web publication is ultimately responsible for it and could reasonably have been expected both to exercise editorial control over it and apply the terms of the Code before publication.
- The material used has not been pre-edited to conform to the on-line or off-line standards of another media regulatory body.

## **REVIEW**

The Editor's Guild of Sri Lanka shall review the provisions of this Code from time to time, in consultation with a Code Committee comprising of members, and non-members appointed by the Guild.

# **RULES AND PROCEDURES OF THE PRESS COMPLAINTS COMMISSION OF SRI LANKA**

## **A. MAKING A COMPLAINT**

1. Any person who reasonably believes that he or she or another person/s have been adversely affected by any published item including a news story, article, photograph and/or graphic ("Published Item"), that appeared in a newspaper or a magazine or a Journal or an Online edition thereof published in Sri Lanka may make a complaint to the Press Complaints Commission of Sri Lanka ("PCCSL"). Such complaint shall satisfy the following requirements:

- (a) it shall be in the prescribed complaint form, which may be downloaded from the PCCSL website, at [http://www.pccsl.lk/make\\_complains.php](http://www.pccsl.lk/make_complains.php);
- (b) it shall be a concise statement in writing, describing the issue and shall be duly signed by the complainant;
- (c) it shall be communicated to the PCCSL in person, by registered post, facsimile, e-mail or any other electronic means;
- (d) any Published Item/s in an online edition (website) can either be downloaded and a print out obtained and/or forwarded to the PCCSL if such Published Item is available on the online edition and or traced from any archive of the online edition or any link to that online edition.
- (e) the Published Item alleged to have affected the complainant adversely shall be annexed to the complaint; provided however, that where the complaint is made via e-mail or any other electronic means, the complainant shall attach the Published Item to the complaint.
- (f) Where the complainant is unable to find a copy of the Published Item, the PCCSL Secretariat shall make every endeavour to assist the complainant in finding such Published Item.

2. (a) The complainant may request the PCCSL to:

- (i) settle a dispute by conciliation
- (ii) settle a dispute by mediation; or
- (iii) refer the matter for adjudication by arbitration

Provided however that in the event that pursuant to action taken by the Dispute Resolution Council of the Commission (hereinafter referred to as the "Council") as set out under (7) below, the editor of the relevant newspaper, journal, magazine or online edition thereof agrees to publish a correction and/or apology and/or a right of reply, which in the Council's view addresses and rectifies the issue complained about, the parties shall not proceed to conciliation, mediation and/or arbitration.

(b) Where the complainant requests the PCCSL to refer the matter for adjudication by arbitration, the complaint must, in addition to the requirements set out under (1) above, satisfy the following requirements:

- (i) the material facts and circumstances of the dispute shall be set out;
- (ii) a statement of evidence shall be provided; and
- (iii) the relief sought by the complainant shall be specified.

3. A complaint made against any Published Item after one year from its publication shall not be entertained by the PCCSL.

## **B. THE ROLE OF THE COUNCIL**

4. The Council shall accept a duly received complaint only if it deems, at its complete discretion that the Published Item referred to has breached the Code of Professional Practice of the Editors Guild of Sri Lanka for the time being, as adopted by the Sri Lanka Press Institute ("SLPI") and the PCCSL.

5. Where the members of the Council are of the opinion that the Published Item has not breached the Code of Professional Practice of the Editors Guild of Sri Lanka, it shall reject the complaint and provide reasons therefor in written form, to the complainant within two (2) weeks of receiving the complaint. In the event that notice of refusal has not been provided to the complainant it shall be deemed that the complaint has been accepted by the Council with effect from the date on which the same was received by the Council.

6. Once the complaint is accepted, the Council shall within one (1) working day thereof, communicate the same to the editor of the newspaper, journal, magazine or online edition thereof which contained the Published Item which allegedly adversely affected the complainant, along with a copy of the complaint. The Council shall, along with such communication call on the said editor to act on the complaint and/or reply to the Council on the complaint within a period of five (5) working days of receiving the communication.

7. In the event that the editor of the newspaper or magazine to whom the communication is made as aforesaid, does not respond to the same by the due date, the Council shall forthwith directly refer the complaint to the publisher for action on the matter and/or a reply to the Council; provided however that where the editor or the publisher (as the case may be), or a person acting for and on behalf of such editor or publisher requests for time to reply, such further time may be granted by the Council at its discretion.

Provided further, that if a correction and/or a right of reply is published in the newspaper, journal, magazine or online edition, it would be deemed to be a reply.

8. The Council shall make all endeavours to facilitate the parties to enter into a settlement within the shortest period of time, but not later than two (2) weeks from the date of accepting the complaint.

### **C. CONCILIATION**

9. Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by conciliation, the Council shall refer such request to the Chief Executive Officer of the Council (CEO) for conciliation. A settlement agreed upon by the parties may include a correction and/or apology and/or a right of reply.

10. Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of the CEO to whom the matter is referred for conciliation, the CEO shall disclose such circumstances to the Council in writing and the Council shall refer the complaint to a member of the Council for conciliation.

11. In the event that the Council is of the opinion that the matter is not likely to be resolved through conciliation, the Council may propose, for the consideration of the parties, other means of resolving the dispute.

### **D. MEDIATION**

12. Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by mediation, the Council shall refer such request to the CEO or three members of the Council for mediation.

13. (a) Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of the CEO or a member of the Council to whom the matter is referred for mediation, the CEO or the member of the Council (as relevant) shall disclose such circumstances to the Council in writing and shall not act as mediator in such matter;

(b) In the event that such a written disclosure of interest in the matter is provided by the CEO or any member of the Council (as relevant) appointed to mediate the matter, as stipulated in (a) above, the Council shall appoint another member of the Council in place of the member withdrawing.

14. In the event that the CEO or the Council is of the opinion that the matter is not likely to be resolved through mediation, the Council may propose, for the consideration of the parties, other means of resolving the dispute.

15. The Council shall determine the procedure for mediation so as to facilitate an expeditious and economical resolution of the dispute by mediation. In general:

- (a) each party shall be given a fair hearing and an opportunity to present its case in conformity with the principles of natural justice;
- (b) a dispute shall be settled within two (2) weeks of the date when the dispute was referred to the CEO or three-members of the Council (as relevant), however this period may be extended at the request of the parties;

16. Mediation proceedings shall terminate:

- (a) upon the parties reaching a settlement agreement;
- (b) upon a declaration issued by the Council on the recommendation of the CEO or the three members of the Council (as relevant) appointed to mediate the matter, stating that it is unlikely that the proceedings would lead to the resolution of the dispute; or
- (c) upon a written request by any one of the parties requesting for the termination of mediation proceedings.

In the event that mediation proceedings terminate on the grounds provided under (b) and (c) above, the Council shall refer the matter for arbitration by the Council as provided for under Part E below; provided however that a member who was involved in mediation proceedings shall not be appointed to the panel of arbitrators.

Provided however that a complainant may withdraw the complaint should he or she not be willing to proceed to arbitration.

## **E. ARBITRATION**

17. The request made to the PCCSL by a complainant to arbitrate a dispute between himself and a member of the PCCSL, arising from any publication in the press of Sri Lanka, or the consent of the complainant to any referral for arbitration made by the Council in terms of clause 11 or clause 16 above, together with the deemed consent of the member of the PCCSL in terms of article 12 of the articles of association of the PCCSL, shall be deemed to be an arbitration agreement” within the meaning of the Arbitration Act No. 11 of 1995 between the said member of the public and the particular member of the PCCSL to refer such dispute for resolution by Arbitration.

18. Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by arbitration, or where the Council has referred the matter for arbitration further to clause 11 or clause 16 above, the Council shall appoint a three (3) member panel of the Council as arbitrator and refer the dispute to such panel for arbitration.

19. Where the parties to the dispute object to the appointment of one or more of the member/s constituting the panel the Council shall appoint another member or members of the Council in place thereof.

20. (a) Where the three member panel of the Council sits as the arbitrator:

- (i) the quorum for any adjudication thereby shall be two (2) members;
- (ii) the Council shall always maintain a non-press related members majority; and
- (iii) the majority opinion shall prevail, provided that in the event a matter is taken up by two (2) arbitrators forming the quorum, a decision shall require unanimity.

(b) The three (3) member panel of the Council may, at its discretion, refer any matter to a fuller panel with the consent of the parties. The quorum in such event shall be two (2) members less than the composition of the relevant panel.

21. Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of any member of the Council to whom the matter is referred to for arbitration, such member of the Council shall disclose such circumstances to the Council in writing and shall not act as arbitrator in such matter.

In the event such a written disclosure of interest in the matter is provided by the member of the Council appointed to arbitrate the matter, as stipulated in (a) above, the Council shall appoint another member of the Council in his/her place.

22. The Council shall determine the procedure for arbitration so as to facilitate expeditious and economical resolution of the dispute. In general:

- (a) each party shall be given a fair hearing and an opportunity to present its case in conformity with the principles of natural justice;
- (b) at the request of the arbitrator, the parties shall state the evidence on which they wish to rely on, specifying what they wish to prove thereby;
- (c) the Council shall require the parties to the dispute to be comprehensive in any or all statements submitted and in case the complainant fails to comply with such requirement, the arbitrator may at his discretion dismiss the case; provided however that in the event the relevant editor and/or publisher fails to comply with the said requirement, such failure shall not prevent the continuation of proceedings;

(d) in the event that a party fails to appear at a hearing or otherwise comply with an order and does not show valid cause for such failure, such failure shall not prevent the arbitrator from proceeding with the case or rendering an award;

23. The arbitrator shall grant an arbitral award in accordance with the following:

(a) the powers of the arbitrator to award relief in arbitral proceedings shall be limited to making an order to the editor and/or publisher to publish a right of reply and/or correction and/or apology in the media in which the relevant publication took place, unless the power to award any other relief is expressly conferred on the arbitrator in writing by the parties. Provided however that the arbitrator may specify a date and/or a page number and/or placement on a particular page of the said publication including online editors for the execution of the arbitral award;

(b) an arbitral award shall be made after having conscientiously considered and evaluated all aspects of the proceedings and after the arbitrator determines what has been proved in the case;

(c) an arbitral award shall be made not later than one (1) month from the date on which the matter was referred for arbitration;

(d) a separate issue or part of the matter in dispute between the parties may at the request of a party be decided by a separate award; provided however that where the other party objects to the same, a separate award may be rendered by the arbitrator if it is deemed that there are exceptional reasons therefor;

(e) where a party has partially admitted a claim, the arbitrator may give a separate award on the part that has been admitted;

(f) in the event a settlement is made, the Council may at the request of the parties, confirm such settlement in the award.

(g) a correction, change or interpretation of the award may be given effect to in the following circumstances, provided that the relevant parties to the arbitration have been presented an opportunity to express their views:

(i) any obvious miscalculation or clerical error in an award shall be corrected by the arbitrator;

(ii) the arbitrator may decide a question which should have been decided in the award but which was not decided therein, in the event that a party to the arbitration requests for the same within thirty (30) days of the award;

(iii) the arbitrator may provide an interpretation of the award in writing provided that the same is requested for by a party to the arbitration within thirty (30) days of the award;

24. An arbitral award by the Council of the PCCSL is equivalent to an award by an arbitral tribunal under the Arbitration Act No. 11 of 1995. As such, an arbitral

award by the Council may be enforced in terms of the Arbitration Act No. 11 of 1995, by applying to the High Court within one (1) year following the expiry of fourteen days from the date of the award.

25. The fee and costs of arbitration shall be decided by the Council and the Council shall prescribe how and by whom such fees and costs shall be paid.

26. Once arbitration proceedings close, the arbitrator shall submit to the PCCSL, a copy of the award as well as a record of all proceedings.

## **F. MAINTENANCE OF RECORDS**

27. The CEO shall maintain records of all complaints including telephonic and verbal communications relating thereto and decisions of conciliation, mediation and arbitration proceedings, and shall make available to the PCCSL an annual report of the complaints made, adjudicated and pending, which will be made available to the public thereafter by way of a publication by the PCCSL.

## **G. NOTICES**

28. Any document, addressed to the PCCSL and sent by courier or by registered post shall be deemed to be given, made or received by the PCCSL on the day it was so delivered or on the day following that on which it is posted as the case may be.

29. The spokesperson for all complaints received and decisions made by the Council will be the CEO, provided however that the CEO may consult the chairman of the Council where it is prudent to do so. In any event no details will be provided to the press and/or electronic media and/or public regarding on-going inquiries, and no interpretation of any arbitral awards made by the Council will be made by the CEO unless after consultation with the chairman of the Council and/or arbitrator.

30. All press releases and verbal statements on matters relating to the PCCSL, made to the public and/or other media, by the CEO will require the prior sanction of the chairman of the PCCSL provided that if they relate to any matter involving a complaint, the provisions of clause 29 shall apply.

## **H. REVISION OF RULES**

31. These procedures will be reviewed annually or as and when required and if necessary revised and submitted by the CEO to the Council for approval and to the Board of Directors of PCCSL for ratification and implementation.

(b) I/We have received a copy of the Rules and Procedures of the PCCSL and have read and understood the procedure that will be followed by the PCCSL in addressing the complaint made hereby and prefer that the dispute be settled by: Conciliation/Mediation/Arbitration.

**(C) I/we acknowledge that the settlement arrived at consequent to the conciliation/mediation/arbitration of a dispute shall be final and conclusive and shall not be challenged before any Court of Law or any statutory tribunal, except on a procedural defect.**
